\$111,000 grant to Los Alamitos Unified School District (the "District") to provide in-classroom support to mitigate reductions in funding from the State of California. Staffing included credentialed teachers working with small groups during math and language arts in grades 4-5, additional sections of math, science and English at Los Alamitos High School, McAuliffe Middle School and Oak Middle school to reduce class size and funding for maintaining a 24-1 student to teacher ratio in K-3 classes throughout the District.

Summer and after school enrichment programs including from academic "jump start" programs for elementary school students, arts programs for grades K-12, Spanish and Mandarin language, SAT preparation, high school academic preparation courses and cooking. Approximately 5% of the students received free or reduced fee courses based on demonstrated financial need.

Provided for credit summer school courses at Los Alamitos High School. Courses were provided at no cost for 15% of the attendees, who were able to demonstrate they were unable to pay course fees.
